



A resolution appointing the presiding judges and alternate judges for the May 3, 2025 Joint General Election and Special Election.

Whereas Texas Election Code Sec. 32.001 states "a presiding election judge and an alternate presiding judge shall be appointed for each election precinct in which an election is held;"

Whereas the City of Victoria usually appoints the polling place presiding judges and alternate judges at the time of ordering the election however, when ordering the election, the polling place presiding judges and alternate judges had not yet been confirmed; and

Whereas in order to comply with the regulations set by the Texas Elections Code, the City must now appoint the polling place judges and alternate judges by resolution of the governing body;

Now therefore, be it resolved by the City Council of the City of Victoria:

1. The presiding election judges and alternate presiding election judges for the Joint General Election and Special Election on May 3, 2025 are appointed as detailed in the attached "Polling Centers and Judges" which is incorporated herein for all purposes.

2. This resolution shall become effective immediately upon adoption.
