Requirements for Sign Permit Applications

- Complete all numbered blanks that are applicable.
- Off-premise Signs (Billboards) require an initial \$150.00 location review fee. A plot plan, deed and an executed contract between the owner and lessee must be submitted.
- On-premise Signs require a plot plan and drawings of the proposed signs. Signs must be set back a minimum of 10ft from the property line to the closest point of the sign structure.
- *Illuminated / Electric Signs must be installed by a licensed and qualified person.
 - Electronic Message Signs with a static message shall not change more than once every 5 seconds and the message in its entirety must change within one second. Electronic Message Signs with scrolling messages shall scroll the entirety of the message within 3 seconds. No portion of the message shall blink or flash.
 - Digital Signs shall display only a static image consisting of a message and background, including all graphics. The static image shall not change more than once every five seconds and the message in its entirety must change within one second. No portion of the message shall blink or flash.
